

1999-2000 Waterfowl Hunter Survey

Summary

The Wildlife Division conducted a waterfowl hunter survey following the 1999-2000 hunting season to better understand waterfowl hunter's opinions and attitudes on waterfowl hunting seasons, bag limits and other related waterfowl hunting issues. From the 12,800 hunters that registered in 1999 through Virginia's Harvest Information Program (HIP) and indicated they had hunted ducks, geese, brant or swan in Virginia, 3000 (23%) were mailed questionnaires. Questionnaires returned totaled 1261 (42% response). Not every question was answered by each respondent. A complete report of the survey results will be available in the near future. Below are a few results that are pertinent to setting seasons and bag limits.

Duck Seasons

October Segment

- Timing of October Segment - 50% favored putting October segment in 2nd week of October versus 31% in support of putting it as early in the month as possible. Total elimination of the October season was opposed to strongly opposed by 55%.
- Number of Days - Surprisingly the most preferred options was for 5 days in October (48% support). The second most preferred was the 4-day option (33% support).

Bag Limits

- Respondents favored 5-duck bag (55%), over 4-duck bag (51%), and 6-duck bag (45%).

Black Duck Closure

- Respondents favored December closing (42%) slightly over Nov-Dec closing (39%), and opposed late (Jan 3-20) closure the most (41%).

Hunting Opportunity

- Respondents favored more days versus a higher bag limits when faced with more or less duck hunting opportunity (65% favored a 70 day season 5 ducks in the bag over 60 days and 6 ducks (18%); 67% favored 60 days and 4 ducks over 50 days and 5 ducks (19%)).
- Respondents favored having seasons extend as late into the framework as possible.
- In general, 65% of respondents indicated they were satisfied with duck hunting season frameworks as they currently exist and only 20% indicated they were dissatisfied.

Youth Hunting

- Only 9% of respondents took a youth hunting on youth waterfowl day.
- When asked how often they had taken a youth waterfowl hunting during the 1999-2000 season, 75% of the respondents answering the question reported that they never did, 15% indicated they took a youth hunting 2-5 days, 8% indicated 1 day and 5% reported more than 5 days.

The state can be more restrictive than the Federal Frameworks, but we must stay within these federal guidelines. Opportunity (Q#18)

- Respondents favored more days versus a higher bag limit when asked 2 different ways.

Canada Geese (note: limited application to current framework)

Season Timing (Q#21)

- Respondents favored a later season when only 6 days were available: Jan 14-20 was most supported (50%) versus 40% or 41% for earlier options (Jan 1-6, Dec 28-Jan 3).

Youth Hunting

- Only 9% of respondents took a youth hunting on youth waterfowl day.
