Certification of Closed Meeting

WHEREAS, Section 2.2-3712.D of the Code requires a certification by this Board that such closed meeting was conducted in conformity with Virginia law;

NOW, THEREFORE, BE IT RESOLVED that the Board of Wildlife Resources hereby certifies that, to the best of each member's knowledge, only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification resolution applies, and only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered by the Board.

WHEREAS, The Board of Wildlife Resources has approved the acquisition of an open space/public access easement on up to +/- 150,000 acres currently owned by the Cumberland Forest Highlands, LLC, in Buchana, Dickenson, Wise, and Russell counties; and

WHEREAS, procedures established by the Virginia Tobacco Region Revitalization Commission require the Applicant's Governing Body to certify by resolution the approval of the Applicant to apply for Southwest Virginia Grants funds; and

WHEREAS, this project appears consistent with the intent of the Commission's grant program intent to make investments to revitalize and diversify the economy of the region it supports, particularly in the areas of business development, sites, and infrastructure, and tourism;

NOW, THEREFORE BE IT RESOLVED by the Board of Wildlife Resources of the Commonwealth of Virginia that the Board does hereby:

 Approve the filing of an application by the Virginia Department of Wildlife Resources (Department) for a Virginia Tobacco Region Revitalization Commission grant; and

- 2. Certifies that the Department understands its legal obligations to the Commission upon approval of the grant; and
- 3. Certificates that the Department will implement the project with diligence once funds are available and the Department has reviewed, understands, and concurs with the Project Agreement; and
- 4. Certifies that the Department will provide the required matching funds (as applicable) and
- 5. Authorizes Department staffs specifically identified by the Executive Director to conduct all negotiations, execute, and submit all documents including, but not limited to, applications, agreements, amendments payment requests, and reports which may be necessary for the completion of the project.
