
Today we have an opportunity to thank them for their service and offer a token of respect.

Support Services:

❖ Division Budget Update

- The division is in the process of developing the FY23 budget. This is a comprehensive process and one that involves critical and strategic thinking. Please feel free to communicate through the chain-of-command any budgetary needs that you feel would enhance your effectiveness.

❖ Communications Center

- We are currently in the process of conducting a background investigation on a new dispatcher and hope to have this position filled as soon as possible.
- We are also patiently awaiting HR to post the new Communications Center Manager position. As a reminder, this position will be a civilian position.

❖ Legal Articles of Interest

- Recently, in [Ingram v. Commonwealth](#), Record No. 1131-20-3 (Dec. 14, 2021), the Virginia Court of Appeals affirmed some well-established principles related to the limits of Fourth Amendment rights where an officer approaches the front door of a residence. In explaining its ruling, the Court stressed that, while law enforcement officers may not enter curtilage to gather evidence, there is a license “implied from the habits of the country” for the general public to approach a home in the hopes of speaking with a resident. Absent the homeowner’s affirmative steps to rescind the invitation, this license typically permits a visitor to approach the home by the front path, knock promptly, wait briefly to be received, and then, absent an invitation to remain longer, leave. The Court went on to note that this license also permits visitors to approach other areas that visitors would be expected to go if the nature of the circumstances surrounding the visit indicate that the visitor could reasonably expect to

seek out residents through areas other than the front door. The Court then expressly noted that this license extends to law enforcement officer. The Court went on to note that, “so long as officers are within the geographic scope of this license, they are free to keep their eyes open.” In other words, the Plain View Doctrine applies because the officer is legally authorized to be there.

- The facts of this case are not remarkable.

- I would like to share with each of you what I shared with our dedicated staff that worked the 74th Gubernatorial Inauguration. This was a very impressive and prideful moment for the Agency and the division:

“Wow! I am not sure I have been more proud of this division and our ability to come together and represent the Agency and Commonwealth in such a professional manner. Saturday was one of the coldest days we have experienced all winter and you all were tasked with enduring those temperatures during a long shift. Whether you stood a post, pulled a truck and boat in the parade, or handled your K9 partner, you all contributed to the success of the event and cast a very bright spotlight on the Department of Wildlife Resources and the Virginia Conservation Police. Thank you for your dedication and professionalism in what was a historical event for this division!”

- Even though this was a team effort, every team has a leader. LT Hickman was assigned to be the operational lead for planning our participation. Throughout the planning period of the event, LT Hickman did an excellent job

of representing the division and seeing that all aspects of our participation were well coordinated. This was complicated by the fact he was charged with scheduling all security posts, which were impacted numerous times by COVID-19. He was also tasked with coordinating the presence of a patrol truck and boat in the parade, as well as the honor guard. In addition to the planning aspect, LT Hickman made multiple trips to the site of the event to walk through to make sure we would not experience any unforeseen issues. To take it one step further, he was also charged with planning our participation in Lobby Day the following Monday, which was another large scale operation involving hundreds of law enforcement officers. Ultimately, this event, which is really a historical event for the division, went off without a hitch. The success of the event can be attributed to LT Hickman's leadership and attention to detail both during the planning and operational phases of this event.

Colonel's Message:

I just came back from a "Game Warden Experience", dedicated to Waterfowl Enforcement. Much has changed in my 27 years as a Game Warden and CPO, but migratory birds still need our protection. Our own subject matter experts, Master Officer Brian Bratton, Sgt. Steve Garvis and Resident Special Agent In-Charge (Ret.) Rick Perry, did an outstanding job of demonstrating effective techniques in collaboration with our partners at the US Fish and Wildlife Service.

This is a training initiative designed to focus on traditional boots-on-the-ground techniques using a hands-on approach over multiple days in the field. With the loss of institutional knowledge, we want you to be successful in your role as a "Protector of Wildlife and Natural Resources", so we are going to invest in each of you since you are our greatest resource. While compliance checks are important, you need to continually hone those surveillance and investigative skill sets, which will lead to better cases. From my experience, there is a significant personal and professional reward in bringing complex investigations to a logical conclusion and we want you all to have the benefit of carrying those rewarding experiences forward and sharing them with others.

We will certainly move forward with more of these Game Warden Experiences. Sgt. Steve Garvis has agreed to facilitate these special training field sessions to ensure they consistently offer the elements and opportunities that our first one fulfilled, to include; sharing our expertise in a team environment where you will also have some fun. Some other ideas for GW Experiences include: Trapping, Bear Bait, Turkey, Ginseng and Turtle Poaching. If you have an idea, or want to assist in any way with one in the future, please let Steve know.

Proactive Initiatives:

- **VCP Career Progression Program (CPP) Update**
 - We have received a response from DHRM on our career progression program with some additional questions. DHRM did state that they fully support the establishment of a career progression plan for CPOs at DWR. We are currently working on a response that will include the additional information that they requested. Stay tuned!
- **Development of Beard and Updated Grooming Standards**
 - General Order 03-03 Uniforms and Personal Appearance is currently under revision to represent the new uniform items as well as developing new facial hair guidelines and new consideration for female officer hairstyles.
- **North American Wildlife Law Enforcement Accreditation (NAWLEA)**
 - Alabama, Arkansas, Florida, Georgia, South Carolina, Texas and Virginia as a coalition of South Eastern Natural Resource Law Enforcement Agencies are in the process of creating NAWLEA to address the uniqueness of natural resources law enforcement. Many of the standards are already consistent with those of VLEPSC and Florida's state accreditation body. The development of this accreditation body will create a network of agencies working together to enhance natural resources law enforcement on a national level.
- **New Firearm Issued**
 - We are getting very close to issuing our new Glock 45 MOS duty weapons. Currently, everyone should have signed-up for a range date next month.
- **Outer Carrier Issued**
 - The Agency has been assigned a new Safariland representative that recently made a visit to HQ. A topic of discussion was the delay on the outer carriers. Fortunately, our new representative was able to work through some issues and we should have the remaining carriers in time for our firearms transition.
- **New Uniforms**
 - The new uniforms have started to roll into HQ. We are currently working on a strategy to get these bulk ordered uniforms organized by officers. We hope to start rolling these out into the field within the next 30-60 days.
- **New Watercraft Regulation that benefits LE** - Special thanks to SGT Goszka!
 - The law enforcement division, with the assistance of Tom Guess, has crafted a proposed regulation that will require *“Every motorboat, when approaching or passing within 100 feet of any law enforcement vessel or emergency services vessel that is displaying flashing blue or red lights, shall slow to no wake speed so that the effect of the wake does not disturb the activities of law enforcement or emergency services personnel.”*

- This proposed regulation still has a long way to go before it is published, and it may not make it, but we are committed to providing you all as much protection as possible when you are on the water.

❖ Recruitment / Retention Initiatives

- DWR is planning to hire 25 new officers this year. Meetings are underway that will set the hiring process specifics - including announcement date, the hiring timeline, and the list of duty station locations. ❖ Training (Basic and In-service) / Training Offered to Other Agencies

- The 11th Academy is completing Week 21. Since the last Roll Call update, the students completed their Officer Water Survival and Firearms training.

The students completed the 16 hour NASBLA Officer Water Survival (OWS) course in accordance with the National Association of State Boating Law Administrators (NASBLA) Boat Operations and Training (BOAT) Program. The purpose of the course is to provide our new officers the skills necessary to survive in and around the water. This course prepares the officer for the unexpected immersion into the water. A key element of this course will be the preparation of participants to become proficient in water survival skills and awareness on how to use their duty gear and survival equipment to increase their chances of survival. The students demonstrated proficiency of each of the subject areas outlined in the course modules through a compilation of measures including objective testing, scenario review, class discussion, practical activities and verification of course prerequisites.

The NASBLA OWS program is in place by many agencies across the country, and was added to the Basic Training Academy's curriculum in 2021.



The Basic Academy has also completed their 10 day firearms training program at the Virginia State Police Facility in Blackstone. The students learned firearm nomenclature and maintenance in the classroom prior to heading out to range. During this training, each student demonstrated their proficiency with the issued Glock 45 pistol and Colt M4 rifle during daytime and low-light conditions.

- The students of the Modified Academy are currently in their field training phase of their training. They are assigned to veteran officers who are providing guidance and coaching to prepare them for the career ahead.

- The Training staff met with their new DCJS representative this past week. Due to regulation changes, our new representative will meet regularly with Academy staff to discuss the program and to sit in on training courses.
- VCP Leadership Training - the Law Division promotes leadership throughout its levels. In support of this, several courses have been identified and our officers are encouraged to pursue the opportunities. The courses include in-person offerings by FBI-LEEDA and online offerings through the Commonwealth of Virginia Learning Center.
- Basic Field Training Officer Certification Course- This 32 hour course will introduce our officers to the concepts of problem-based learning, while developing facilitation, leadership, and coaching skills. The training will promote adult learning principles and varied individual-based training approaches designed to maximize valuable field training time, overcome training challenges, and allow the officer in training to learn at the appropriate individual pace.
- Colt Rifle Armorer Course- the Law Division had issued the Colt M4 rifle to its field officers. To ensure these firearms are properly maintained, we have arranged for instructors from Colt to deliver this 24 hour course to our firearms instructors. These officers will gain a complete understanding of the design theory, nomenclature, dynamics, compatibility, interchangeability, detailed disassembly, assembly, maintenance and trouble-shooting of the M16/AR-15 family of weapons including rifles, carbines, and sub-machine guns. This class provides a certification that is valid for 3 years. Officers from DCR and VMRC have been invited to attend the course.
- DWR officers will be teaching DCR officers at Westmoreland State Park how to operate ATV's in March. This training will cover several important topics including department policy, officer safety, maintenance, and operation at varied speeds in over terrain.

Support Services:

- ❖ Grants
 - We have already begun the project research for the 2022 Port Security Grant process and are working on identifying the projects that will be included in the grant application. Even though this grant application process specifically focuses on Region 1 assets, it allows the division to reallocate state funds, which benefits the entire division.
 - The 27' SAFE boat that we acquired based on the 2020 PSGP grant award has been marked and is awaiting STARS radios. She will be on patrol very soon in the Middle Peninsula!



❖ Communications Center

- The process to fill the vacant dispatcher position has been delayed due to some unforeseen complications. Fortunately, we have extended another offer, which has been accepted and we will be working to conduct a background investigation on the applicant in the near future. In reference to the communication center management position, that position closed on the 13th and we are awaiting the list of screened applicants from HR.

❖ Legal Articles of Interest

- The Supreme Court of the United States decided three Fourth Amendment cases in 2021 – Lange v. California, 141 S. Ct. 2011 (2021), Caniglia v. Strom, 141 S. Ct. 1596 (2021), and Torres v. Madrid, 141 S. Ct. 989 (2021).
- The Lange case has been discussed in a prior edition of this newsletter. You may recall that the Court explained that “[t]he flight of a suspected misdemeanor does not always justify a warrantless entry into a home.” Lange, 141 S. Ct. at 2024. The Court cautioned that “[a]n officer must consider all the circumstances in a pursuit case to determine whether there is a law enforcement emergency.” Id. Even so, “[o]n many occasions, the officer will have good reason to enter—to prevent imminent harms of violence, destruction of evidence, or escape from the home.” Id. “But when the officer has time to get a warrant, he must do so—even though the misdemeanor fled.” Id. The underlying facts in this case are that an officer gave chase to Mr. Lange after he drove by the officer playing loud music and honking his horn. Within 100 feet of commencing the chase – a four second drive, Lange turned into his driveway and entered his attached garage. The officer entered the garage and immediately conducted field sobriety tests, leading to a misdemeanor charge. The Court held that, under these

circumstances, the officer violated Mr. Lange's Fourth Amendment rights by the warrantless entry into his home.

- In Caniglia, the Court held that the "community-caretaking" exception to the Fourth Amendment, set forth in Cady v. Dombrowski, 93 S. Ct. 2523 (1973), does not extend to the home; a warrant is still required here. In Cady, the Court held that a warrantless search of an impounded vehicle for an unsecured firearm did not violate the Fourth Amendment. Cady, 93 S. Ct. at 2532. The Court noted that, "[i]n reaching [its] conclusion [in Cady], [it] observed that police officers who patrol the 'public highways' are often called to discharge noncriminal 'community caretaking functions,' such as responding to disabled vehicles or investigating accidents." Caniglia, 141 S. Ct. at 1598 (citing Cady, 93 S. Ct. at 2523). That said, the question before the Court in Caniglia is "whether Cady's acknowledgment of these 'caretaking' duties creates a standalone doctrine that justifies warrantless searches and seizures in the home." Caniglia, 141 S. Ct. at 1598. The Court held that "[i]t does not." Id.
- The germane facts in Caniglia are that, during an argument with his wife, Caniglia placed a handgun on the dining room table and asked his wife to "shoot [him] and get it over with." His wife instead left the home and spent the night at a hotel. The next morning, she was unable to reach her husband by phone, so she called the police to request a welfare check. The responding officers accompanied Caniglia's wife to the home, where they encountered Caniglia on the porch. The officers called an ambulance based on the belief that Caniglia posed a risk to himself or others. Caniglia agreed to go to the hospital for a psychiatric evaluation on the condition that the officers not confiscate his firearms. But once Caniglia left, the officers located and seized his weapons. Caniglia sued, claiming that the officers had entered his home and seized him and his firearms without a warrant in violation of the Fourth Amendment. The District Court granted summary judgment to the officers. The First Circuit affirmed, extrapolating from the Court's decision in Cady v. Dombrowski, a theory that the officers' removal of Caniglia and his firearms from his home was justified by a "community caretaking exception" to the warrant requirement.
- In Torres, the Court held that a suspect who was shot by police while fleeing the scene in her vehicle was seized within the meaning of the Fourth Amendment because the application of physical force to the body of a person with intent to restrain is a seizure, even if the force does not succeed in subduing the suspect. The officers' shooting applied physical force to the suspect's body and objectively manifested an intent to restrain her from driving away, so the officers seized the suspect for the instant that the bullets struck her.

- This ruling came about in a case brought by Torres against the officers who shot her. The legal rationale is quite convoluted. Thus it precludes meaningful summary here.
- The germane facts in Torres are that Janice Madrid and Richard Williamson, officers with the New Mexico State Police, arrived at an Albuquerque apartment complex to execute an arrest warrant and approached Roxanne Torres, then standing near a Toyota FJ Cruiser. The officers attempted to speak with her as she got into the driver's seat. Believing the officers to be carjackers, Torres hit the gas to escape. The officers fired their service pistols 13 times to stop Torres, striking her twice. Torres managed to escape and drove to a hospital 75 miles away, only to be airlifted back to a hospital in Albuquerque, where the police arrested her the next day. Torres later sought damages from the officers under 42 U.S.C. § 1983. She claimed that the officers used excessive force against her and that the shooting constituted an unreasonable seizure under the Fourth Amendment. Affirming the District Court's grant of summary judgment to the officers, the Tenth Circuit held that a suspect's continued flight after being shot by police negates a Fourth Amendment excessive-force claim. However, the Supreme Court disagreed, holding that the application of physical force to the body of a person with intent to restrain is a seizure even if the person does not submit and is not subdued.

- The Division, in conjunction with Leon Boyd, who serves as an Agency Board Member and the Ward Burton Wildlife Foundation, developed and conducted a social media outreach initiative focused on closing a very significant wildlife case that involved a mature bull elk that was poached in the War Fork area of Buchanan County. This effort has led to some additional information and officers in Region 3 are actively working this case.

Bull Elk Taken Illegally in the War Fork Area of Buchanan County

- Commendation Letter from Virginia State Police Superintendent Colonel Gary Settle and goes to Lieutenant Rob O. Ham III; Sergeant Chance Dobbs; Senior K-9 Officer Ian Ostlund and K-9 Reese; Master K-9 Officer Richard Howald and K-9 Sky; Sergeant Ken Williams; Officer First Class Phillip Pritt; and Officer First Class Justin Sumpter

This Citizen Feedback Submission read, "The death of any police officer in the line of duty represents a tragedy of the highest order. The actions of the offender represent not only an attack against the individual officer, but an attack on the fabric and order of our nation and society. Sadly, this is the situation which unfolded on the afternoon of February 1, 2022, on the campus of Bridgewater College when two law enforcement officers from the college police force were shot and killed by an assailant. College Police Officer John Painter and Campus Safety Officer J.J. Jefferson were in the process of responding to a call for a suspicious person when they encountered Alexander Wyatt Campbell outside of Memorial Hall. During this encounter, Campbell produced a firearm and fatally shot both officers. Campbell then proceeded to take Officer Painter's handgun and flee the scene. Through the quick work of responding state and local law enforcement, Campbell was quickly contained and taken into custody on an island in the North River. Campbell has subsequently been charged with multiple felonies in connection with this fatal assault.

Several members of the Virginia Department of Wildlife Resources Conservation Police were among the responding law enforcement personnel. They bravely responded when the calls for assistance were broadcast and remained on scene as members of the Bureau of Criminal Investigation, Culpeper Field Office progressed through the investigation and processing of the crime scene. In particular, supervisors from your agency arranged for assistance from several of your K-9 teams to assist in performing article searches and tracks of the offender's movements. It was through this assistance that an area in the river was identified for search, which resulted in the locating of Officer Painter's stolen handgun. As such, I would like to formally recognize:
