Colonel John Cobb gave a Law Enforcement Update:

- We currently have 25 recruits, now in week 18 (Graduation on July 20)
 - o Academy Sergeant left agency (interviews next week)
- Fleet Management Update challenging to have 25 vehicles ready by graduation
 - Support Services Major left agency (Notice of Vacancy goes out tomorrow)

- In terms of CPO Retention, during the recent 8 weeks stretch, eight officers left agency
 - o Since June of last year, total of 20 CPO's left agency (only 4 retirements)
- ▶ Plan to start next officer recruitment soon with 25 recruits beginning February 25, 2024
- ➤ Last week attended WV Natural Resource Police K-9 Graduation; we trained 6 officers and their dogs over 9 weeks
 - o First time they have had a K-9 Program in their 125 year history
 - o Presented items that WV Natural Resources presented Law for their help
