Wildlife Division Update: The Chair called on Deputy Director Becky Gwynn for an update.

Ms. Gwynn reported:

- The Department has received (2) \$100,000 Grants for Wetland Projects
- DWR staff in Region 4 and the VA Chapter of the American Bear Foundation are working together with the help of the hunters on the Bear population
- Falcons will be banded in downtown Richmond on Friday 5/26/23, attending will be the Director and Ms. Gwynn and staff from the Secretary of Natural Resources office
- The Sea Birds are back at Ft. Wool, somewhere upwards of 3,500

After comments and questions, the Chair thanked Ms. Gwynn for her update.

Mr. Sadler arrived at 11:55 am.

Fish Division Update: The Chair called on Dr. Mike Bednarski for an update.

Dr. Bednarski reported:

- Free Fishing Days, June 1-4
- Stocked 10,000 catfish into our FishLocalVA waters in mid May, These fish are stocked as catchable individuals and provide recreational opportunity for those fishing in developed areas.

- Please join us on June 3 for our annual Free Fishing Days events, which will occur at Lake Burke, Hungry Mother Lake, Dorey Park, and Mt. Trashmore. These efforts are organized by Outreach and supported by the Aquatics staff

After comments and questions, the Chair thanked Mr. Bednarski for his comments.

Boating Division Update: The Chair called on Mr. Tom Guess for an update.

Mr. Guess reported:

- We are in the middle of National Safe boating Week through Memorial Day
- Operation Dry Water is the weekend of July 4 and is a national campaign to target getting impaired boat operators off of the water who are under the influence of alcohol and /or drugs.
- Just returned from the National Boating Safety Advisory Committee meeting in Annapolis MD which is the Federal Advisory Committee for the U. S. Coast Guard. We worked on the National Recreational Boating Safety (RBS) strategic plan and federal regulatory directives and items moving forward.
- The 2022 Virginia Boating Incident Summary is available on our website now. It came out this March.
 - We experienced 87 reportable boating incidents
 - 114 vessels were involved
 - There were 39 injuries
 - 17 fatalities
 - Alcohol was a factor in 23% of the fatalities
 - 29% involved paddlecraft
 - 94% of the fatalities involved people not wearing lifejackets
 - The total of the incidents involved nearly \$500,000 in property damage.

NOTE: for an incident to be reportable it has to involve a fatality, missing person, injury beyond first aid, or damage to the boat or property of a least \$2,000.

Made comments on the economic impact of boating.

After comments and questions, the Chair thanked Mr. Guess for his presentation.

Director's Report: The Chair called on Executive Director Ryan Brown for his report.

The Director reported:

- Thanked Staff for the work and preparation that goes into their presentation for the Regulations to be voted on.
- Commented on the successful turkey season
- Commented on the Elk license planning
- Attended the Front Royal Hatchery Re-Opening

The Chair thanked the Director for his report.

Chair's Report: The Chair thanked everyone for attending the Wildlife and Boat Committee meeting and for the updates and presentations and can appreciate all the work that goes into putting them together.

The Chair also commented and thanked the Board and Staff for attending the Board Retreat at Breaks Interstate Park and how much he enjoyed and appreciated everyone's attendance.

The Chair asked if anyone had any further comments or questions, hearing none, he announced that the next meeting will be Wednesday, August 16, 2023, and adjourned the meeting at 12:20 pm.
