



Disposal Options for Deer Carcasses from Disease Management Area 3



Movement of deer carcasses infected with chronic wasting disease (CWD) across the landscape by hunters is suspected to play a role in the spread of CWD across North America. Hunters are encouraged to discard leftover deer parts into landfills to minimize contamination of the environment with the infectious agent that causes CWD.

Leftover parts of deer harvested anywhere in Disease Management Area 3 should be:

- ✓ **Double-bagged and placed directly in a landfill, a trash receptacle to be picked up with the regular trash collection, or in an approved deer-carcass disposal site (see list below)**
 - ✓ Landfill disposal is the best way to prevent the spread of CWD
 - ✓ Deer waste should be double-bagged in black garbage bags with no deer parts sticking out and bags should not be leaking
- ✓ **Transported only within DMA3. It is illegal to transport whole carcasses out of DMA3**

Approved Deer Carcass Disposal Locations Located in Disease Management Area 3

FLOYD COUNTY

Available to county residents only

MONTGOMERY COUNTY

2. **Montgomery Regional Solid Waste Authority** – 555 Authority Drive, Christiansburg, VA 24073
Mon - Fri: 8 AM – 4 PM; Sat: 8 AM – 12:30 PM
Available to county and non-county residents
This facility requires a fee of \$72/ton or a minimum of \$3.60 for disposal of dead animals

4. **DWR Peppers Ferry Boat Ramp** – 7948 Peppers Ferry Blvd., Fairlawn, VA 24141
Available 24/7 to county and non-county residents
Directions:
 - From Route 11, turn onto route 114 (Peppers Ferry Blvd)
 - Entrance will be 2.1 miles on the right

Mon – Fri: 8 AM to 4:30 PM; Sat: 8 AM to 2 PM; Sun: closed
Available to Carroll, Grayson, and the City of Galax residents

PATRICK COUNTY

6. **Patrick County Solid Waste Transfer Station** – 171 Transfer Station Ln., Stuart, VA 24171
Mon – Fri: 8 AM to 5 PM; Sat: 8 AM to 1 PM; Sun: closed

FRANKLIN COUNTY

7. **Franklin County Landfill** – 9340 Virgil H Goode Hwy, Rocky Mount, VA 24151
Mon-Fri: 7:30 AM to 4 PM; Sat: 7 AM to 12 PM; Sun: closed
Available to county residents for deer harvested within Franklin – Hunters must show proof of residency

ROANOKE COUNTY

Mon-Fri: 7:30 AM to 5 PM; Sat: 8 AM to 1 PM; Sun: closed
9. **Salem Transfer Station** – 1271 Indiana St, Salem, VA 24153
Mon-Fri: 7:30 AM to 5 PM; Sat: 8 AM to 1 PM; Sun: closed

WYTHE COUNTY

10. **Wythe-Bland Joint Public Service Authority** – 169 Kents Ln, Wytheville, VA 24382
Mon-Fri: 7 AM to 3 PM; Sat-Sun: closed
Hunters must check in at scale house and provide proof of harvest/valid tag for disposal
Transfer station will still accept deer without valid tag at a minimum cost of \$20
