

### MILESTONE #1: Stakeholder Assessment

#### Online Survey - IEN

- Specific questions for: (1) Hunters (those who hunt with & without hounds); (2) Landowners impacted by hunting with hounds; (3) Others who are interested in this issue
- Fully open to the public June 5-23, 2023 8,868 survey responses

#### Interviews - IEN

• 18 stakeholders interviewed - interests, concerns, suggestions

## MILESTONE #2: Committee Representatives

- Committee Members bring together the perspectives of:
  - o private landowners
  - hound-hunters
  - o local governments
  - o still hunters
  - Native Americans
  - o agricultural landowners
  - o wildlife management interest groups
- Some Committee Members represent more than one of these perspectives
- 19 Committee seats
- Each organizational body (except for the At-Large Citizen seats) selected its own primary and alternate representatives

# 19 Committee Seats - Representatives

- > 1 representative each for 11 Organizations

  - Virginia Hound Heritage
  - Virginia Hunting Dog Alliance
  - Virginia Property Rights Alliance
- > 5 representatives serving as At-Large Citizen Representatives
- > 1 representative from a Native American Tribe (Upper Mattaponi Indian Tribe)
- > 1 representative each for 2 Local Governments (Louisa & Spotsylvania Counties)

#### **Summary of Survey/Interview Themes**

Survey and Interview Themes are Very Similar.

#### Hunter Themes

- Hunting with hounds has an important, historical legacy in Virginia involving generations of families and has significant community involvement.
- The "Right to Retrieve" law is viewed as an important element to those who hunt with hounds.
- It is acknowledged that there has been and continues to be conflict with landowners and those interactions have had negative consequences.
- New landowners who move to rural areas sometimes do not understand or appreciate the historical significance of hunting with hounds and are not aware of the legal framework in which hound hunters operate. In addition to pressure from new land development, this has contributed to a decrease in hunting opportunities.

#### **Summary of Survey/Interview Themes**

#### Landowner Themes

- The presence of hunters and hounds on their properties has affected their overall quality of life, including disturbances to their peace, concerns for the safety of their children and animals, ability to use and enjoy their property, and the general inconvenience caused by these issues.
- Landowners shared that hunters with hounds often cross properties without permission.
- Law enforcement personnel do not act in a consistent manner on incidents when reported.
- Many landowners support stricter enforcement, revisions to the "Right to Retrieve" law, and better protection of landowners' rights in relation to hunting activities.

#### Survey and Interview Areas of Agreement

- Law enforcement staffing gaps need to be filled.
- Communication between the groups needs to be consistent and transparent.
- Respect and trust are paramount to successful interaction and to reduce potential for conflict.
- Educational efforts for both groups, including new landowners, need upgrading.
- Hunt clubs could enhance communication efforts using a landowner ombudsmen approach program.
- Hound identification mechanisms could be improved.
- Electronic tracking collars should be considered statewide.

### Stakeholder Advisory Committee: Possible Areas of Focus

There was considerable common ground on possible areas for improvement, many of which were discussed in prior stakeholder contributions as well as the current survey and interview process.

- Law Enforcement
- Safety
- Use of Public Lands
- Use of Technology
- Community Engagement
- Continued Work on Ethical Hunting Practices
- Consideration of Other State's Laws

#### First Stakeholder Advisory Committee Meeting

#### Those 7 topics will be our starting place for recommendations.

- Five total meetings are planned.
- Sixteen primary members and 2 alternate members attended.
- IEN presented an overview of the draft Stakeholder Assessment Report.
- Members actively participated and began to identify common ground in their discussion.
- The next meeting will be held on August 31st in New Kent County
